The following Annual Admission Notice has been prepared by the board of Coláiste Chú Chulainn in respect of the admission of students to the school for the school year 2025/2026. This notice was published on 17 <sup>th</sup> October 2024.

<p>All applications to the First Year Group or the Special Class (for ALL year groups in Coláiste Chú Chulainn will only be accepted after the 05/10/2023 and the closing date for receipt of applications is the 10/11/2024. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy. All transfer applications to the Second, Third, Fourth, Fifth- or Sixth-Year Groups in Coláiste Chú Chulainn other than to the Special Class, will only be accepted after the 05/11/2024 and the closing date for receipt of applications is the 10/11/2024. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.</p> <p>Please be reminded that, in line with the school's Admission Policy and the Education (Admission to Schools) Act 2018, all waiting lists going forward are only in place for the academic year to which they apply. Therefore, if a student is seeking a place in the Special Class and is not successful in a given academic year or is on a waiting list for this year, a new application must be made for the following year.</p>	
<b>All applicants to the First-Year Group and/or Special Class will be notified of an offer of a place or refusal of admission by:</b>	17/11/2024
<b>Successful applicants to the First Year Group and/or Special Class must confirm their acceptance of an offer of admission by completing and returning the Acceptance Form on or before:</b>	1/12/2024
<b>Note: Failure to accept an offer of admission before the relevant deadline set out above may result in the offer being withdrawn.</b>
